## New grants and research collaborations

 Dr Emi Nakamura and Dr Dana Carney have been awarded NSF Faculty Early Career Development (CAREER) grants. CAREER awards are among the most prestigious NSF awards in support of junior faculty.

Dr Nakamura has won funding for her project "Integrating Micro and Macro Evidence on Price Dynamics." The proposal focuses on analyzing new micro-data on consumer, producer, and import/export prices to study the effects of monetary policy, cost shocks, and exchange rates on the economy.

Dr Carney's grant will fund her project "How Power Corrupts: Power Offers Immunity to the Emotional, Cognitive, and Physiological Stress of Corrupt Behavior." The research aims to systematically examine the link between power and corruption and to develop realistic, interesting ethics curricula for business students and the business community which are based on sound scientific psychological principles.

Brown Professor of Business, has been awarded the 2011 Outstanding Author Contribution Award by the Emerald Literati Network for his paper "The Effect of Drug Vintage on Survival: Micro Evidence from Puerto Rico's Medicaid Program". The paper is published in Advances in Health Economics and Health Services Research and was selected as it was one of the most impressive pieces of work the editor has seen throughout 2010.

# Overviews on major research funders: Russell Sage Foundation.

Russell Sage Foundation is a private operating foundation which also has a grant-making program. Because it is an operating foundation, it is not permitted to make general operating grants to other organizations and can only make grants to scholars in support of basic social science research within their five principle programs:

- The Future of Work: concerned principally with the causes and consequences of changes in the quality of low-wage work in the United States and other advanced economies.
- U.S. Immigration: aimed at discovering how well immigrants and their children are adapting socially, politically, and economically to life in the United States, particularly as they move beyond the traditional immigrant gateway cities.
- Cultural Contact: concerned with understanding and improving relations between racial and ethnic groups in schools, workplaces, neighborhoods, and other key institutional settings.
- 4. Social Inequality: focused on the social effects of

- rising economic inequality, with particular attention to the ways in which the U.S. political and educational systems have responded to growing economic disparities.
- Behavioral Economics: incorporates the insights of psychology and other social sciences into the study of economic behavior.

The foundation's grants range from \$25,000 to \$500,000 and mainly provide support for analyzing data and writing up results, but it occasionally considers larger awards for data acquisition projects highly relevant to the foundation's program goals.

### **Database Committee and survey**

We would like to thank everyone who completed the recent databases survey, which is the work of the Databases Committee. The objective was to assess usage of existing databases held at the School and gather information on other databases that faculty and doctoral students could use in their research. The results of this survey will help the Committee take steps to improve the databases provision at the School. The Databases Committee is headed by Professor Gita Johar and its membership represents all five School Divisions. ## Human Subjects Research and Institutional Review Board (IRB)

If your research involves human subjects, you need to obtain IRB approval to conduct the research. "Human subject" means a living individual about whom an investigator conducting research obtains: (1) Data through interventions or interaction with the individual or (2) Identifiable private information. Grant applicants need to ensure they have IRB approval or have submitted a protocol for approval at the time of their grant application (or as soon as possible afterwards). This is to prevent delays in the formal award of a grant.

## Columbia Institutional Review Board (IRB) Conference 2011

Dr Modupe Akinola was panelist in one of the plenary sessions on "Deception in research" in the recent 2011 conference organized by Columbia University's IRB. Dr Akinola and her research collaborator, Dr Katherine Milkman (Wharton), talked about their recent controversial research involving deception of study participants and the ways Columbia and Wharton IRBs guided and supported them throughout the process of their protocol submission and approval.

The conference talks addressed a number of topics in Human Subjects research including incidental findings in research, internet research, and student research. Power points of the conference talks are available on the Conference website.

#### **Behavioral Research Lab**

The Behavioral Research Lab is actively involved in the investigation of human decision making and behavior. Members include Columbia faculty, post docs, graduate students, and research assistants.

The Behavioral Research Lab offers a number of useful resources for Columbia Business School researchers. These include: experiment databases used to recruit participants and organize studies both online and off, experiment rooms containing various research tools and technologies, and a team of intelligent lab research assistants eager to gain experience and contribute to the research process. The Lab also organizes occasional educational workshops on research methodologies and tools, and produces a newsletter.
